



MEMBERSHIP APPLICATION FORM

BEFORE COMPLETING THIS APPLICATION WITH RESPECT TO THE CANDIDATE FOR MEMBERSHIP THE PROPOSER SHOULD READ THE FOLLOWING NOTES CAREFULLY.

PROPOSER'S RESPONSIBILITY:

Before proposing a candidate for membership the Proposer should be absolutely satisfied that:

- [a] the candidate is a person suitable for membership of the Club and a person whose conduct as a member, if the application were to be successful, would not be unbecoming or injurious to the character, welfare or interests of the Club;
- [b] the candidate is generally aware of the rules and the conventions of the Club;
- [c] the candidate has a sound knowledge of the rules of golf, the etiquette of the game and the Club's current arrangements in relation to playing rights and conditions;
- [d] the candidate is informed of the facilities and services provided by the Club to its members; and
- [e] the candidate is aware of the current entrance fee and subscription.

GUIDELINES FOR PROPOSER:

The proposer and seconder both must have been members of the Club for at least two years and be personally known to the candidate. Two referees are required, and although members are preferred, external referees are acceptable.

NOMINATION RECOMMENDATION:

The attention of the proposer is drawn specifically to **Item 12** in this application entitled "Nomination Recommendation". The proposer should complete each of the sections under this heading so as to provide a sufficiently full and complete character summary of the candidate to enable the Committee to make an assessment as to the candidate's suitability for membership.

INTERVIEW OF CANDIDATE:

Proposers may be invited to present the candidate for interview at a time to be nominated by the Committee. In addition, the proposer or the seconder may be required to play golf with the candidate and one or more members of a "playing panel" of members, to assist the Committee in assessing the suitability of the candidate for membership.

PROCEDURE:

Any questions which the proposer may have concerning completion of the application or the procedure for consideration and processing of the nomination in respect of which this application is made should be directed to the General Manager.

NOMINATION FEE:

A non refundable administration fee of \$100 is to be paid upon lodgement of the application form.
